Litigation for Good

The most rewarding case I ever handled was for a pro bono client. The client faced a frivolous lawsuit against someone with way more money. The opposing side was represented and intent on steamrolling my client. Emotions ran hotter than any case I'd worked. We had frequent late-night phone calls and weekend meetings. The threat of an unjust result drove me through hours of litigation to prevent it.

But because of the stakes and the value for the client, I loved working on this case. The client prioritized this case over everything else in life and made sure I knew how important my role was. I felt like I was making a big difference to one person and that was refreshing.

Volunteering as an attorney – specifically, a litigator – can seriously impact the lives of people facing injustice. With just some time and our brains, litigators can use a rare (and expensive!) skillset to protect people from harm.

Atlanta is full of good people who need legal protection, such as tenants who need protection from negligent landlords, spouses who need protection from domestic abuse; and, employees who need protection from harassment and wage theft. Litigators can help these people avoid injustice. We can level the playing field by doing it pro bono.

If we can't do it personally, we can do it by supporting our colleagues who work at pro bono legal services organizations.
